



# 2020 Summer Camp Parent Information

Thank you for registering for Summer Science Adventures. We are so excited to engage your child in a week of fun, hands-on science! Here's some information to get you ready for your program:

## What to Bring:

*Please make sure your child's name is written clearly on any items they bring. Things get lost and left behind - help us get your belongings back to you.*

**Lunch:** Bring a lunch that does not require refrigeration or heating. We stay active, so make sure your camper has enough to eat!

**Refillable Water Bottle:** Please bring a reusable water bottle to help stay hydrated. Our drinking fountains are closed so please ensure your camper brings a drink bottle each day.

**Sunscreen and/or bug spray (as needed):** We will have sunscreen available on-site, but encourage you to apply any necessary sunscreen or insect repellent prior to drop-off.

**Extra clothing:** If your child tends to get extra messy, we recommend a change of clothing (this is never a bad idea). PLEASE NOTE: Our staff cannot help children clean themselves if they have a bathroom accident. If the child has an accident and cannot handle cleanup, we will call you.

**Other items:** If your child needs to bring anything else from home, like a hand-fidget, electronic device, toy or book, they are responsible for keeping up with their belongings and putting them away when asked by their instructor. If items become a distraction, we will hold onto them until pick-up time.

**Medication:** If your child needs to take medication during the program, you will complete a medication form during Monday drop-off. Our staff cannot directly administer medication (placing pills in mouths, giving injections aside from assisting with epi-pens), and there is no nurse on staff. All camp staff are CPR/First Aid certified and can provide basic first aid and respond appropriately to emergencies. Aside from soap, water, ice packs, or bandaids, we will not apply any topical medications to scrapes and bumps that occur at camp.

**Face Covering:** Effective July 24, 2020 - All children age 5 and up are required to wear a face mask or face shield while indoors and when not socially distanced by 6 ft outdoors. Please send your camper with a face mask they are comfortable wearing for long periods of time. It's a good idea to pack an extra mask. Eugene Science Center can provide a plastic face shield.

**Rain Jackets:** If rain is in the forecast, please send a rain jacket or poncho with your child. We try not to let the rain keep us inside.

**Snacks:** This summer, OHA recommends campers bring snacks from home. However, snacks will be made available by ESC to those who need them - taking into account any food allergies or sensitivities listed at registration. Picky eaters are encouraged to bring extra snacks from home. Typical snacks are items like goldfish, fruit snacks, popcorn, granola bars, etc. A variety of snacks are also available for sale in the vending machine.

**What to Wear:** Kids should dress appropriately for the weather and be prepared to get messy. Wear shoes that are supportive for walks in the park. **We will be spending time outside each day, so please ensure campers are prepared for cooler weather in the morning and warmer weather in the afternoon.**

**Water Day:** We typically host a water day on Friday afternoons. Kids should wear or bring with them a swimsuit or clothing they can get wet. Campers **MUST** wear shoes during water day, so please ensure your camper has shoes they can get wet or a change of shoes for water activities. Campers should also bring a towel. During the camp day, campers should still be covered up with regular clothing over their swimwear.

## Drop-Off and Pick-Up:

**Drop-Off: Adult caregivers should wear a mask whenever you are onsite at Eugene Science Center.**

Sign-in takes place outside of the front doors or external doors to classrooms whenever possible. Students must be signed in by whoever drops them off. If they are not signed in, we will call you and ask you to come back and sign them in. During drop-off, we can take care of any payments, membership renewals, and medication forms. This summer, we will be screening for fever during drop-off.

**Pick-Up: Adult caregivers should wear a mask whenever you are onsite at Eugene Science Center.**

**Please do not forget to sign your child out! Sign out will take place outside whenever possible.** Our staff reserve the right to check ID for anyone picking up a child from a program. If you need to make changes to your list of authorized adults for pick-up, please let us know.

Parents/Guardians may only enter the building with permission from a staff member and must wear a mask. Restrooms are not available for families or guests of summer campers.

**Gift Shop:** The gift shop will be open for card-only (no cash) purchases on Thursday and Friday afternoons from 3:30-4:30 pm. If your camper wishes to purchase something from the gift shop, you can do so during pick-up.

## Behavior Policy:

*Please review the behavior policy with your child before they attend a program.*

### **Eugene Science Center Rules:**

- 1. Respect Yourself:** Children should not engage in activities that could potentially hurt themselves, such as running or rough housing. They should come ready to learn and have fun, as well as actively participate.
- 2. Respect Others:** Children should be respectful and listen when others are talking. They should also be kind to everyone and not engage in behaviors that hurt someone else's feelings or person.
- 3. Respect the Equipment and Environment:** Children should be careful with all program materials and Science Center exhibits and not engage in any behaviors that could damage the equipment or environment. They should also respect all aspects of the grounds and Alton Baker Park by following

"leave no trace" policies: clean up all trash, making no alterations to the natural environment, and respecting the homes of local wildlife and nesting birds.

### **Consequences for breaking rules:**

Here is how our staff correct behavior. Breaking the same rule after being corrected leads to escalating consequences. These consequences are given compassionately and with the intent to help the camper be successful during camp.

1. Explain the Problem and Redirect Behavior
2. Warning
3. Cool down break
4. Talk with Education Director
5. Conference with Parents
6. Expulsion

*A child who engages in physical violence or threatening language towards another individual or themselves will face immediate expulsion.*

## **COVID-19 Health and Safety Policy**

Policies may be added or changed as the situation in Eugene changes or as we see fit for camp operations. We will be following the state guidelines for summer camp operations.

### **Here are the major changes we are making to camps for the safety of our staff, campers, and community:**

- Camp groups have been limited to 10 children, and individual camp groups will be isolated from other groups on site. For example, camps for 1st-2nd graders will not interact with camps for 3rd-4th graders. Any shared items or surfaces used by campers will be sanitized before being used by a new group.
- Increased cleaning and sanitizing of the entire facility, including classrooms, restrooms, exhibit hall, planetarium, and outdoor benches and tables.
- Unfortunately, we are not able to comply with state guidelines regarding early and late care, so all sessions of Early (7:30am – 9:00am) and Late (4:00pm – 5:30pm) Care will be canceled. If you are registered for early or late care, you will be unregistered from them.
- We will have a drop-off window of 8:30am – 9:00am and a pick up window of 4:00pm – 4:30pm for all camps.
- Parent drop-off and pick-up will take place outdoors whenever possible.

- Camp activities will take place outdoors as much as possible, and campers will be socially distanced in classrooms.
- Camp staff will check temperatures of campers during drop-off.
- Campers with a temperature over 100.3° or other COVID-19 symptoms (unrelated to a pre-disclosed medical condition) such as cough, shortness of breath or difficulty breathing; fever; chills; muscle pain; sore throat; diarrhea; and new loss of taste or smell will not be allowed to attend camp.
- Campers who consistently and deliberately refuse to follow health guidelines will be sent home.
- Effective July 24, 2020 all campers are required to wear a face covering. Campers will be responsible for their own masks brought from home and must be capable of independently taking masks on and off and properly wearing masks.
- We are providing child-size face shields for individual use, and using transparent sneeze guards for table work. Face shields are optional for campers, but are required when not wearing a mask.
- Camp staff are prepared to provide a safe environment using positive reinforcement, compassionate encouragement, and lots of fun!

During Monday drop-off, you will review a camper safety agreement with your child. Kids who accidentally break a health safety rule will not be punished, and we will give consistent reminders in a positive, mindful manner for preventing the spread of germs.

## Cancellation Policy

Cancellations made at least one week prior to the start of a program are eligible for a full refund or credit, minus a \$10.00 cancellation fee. Cancellations after that are eligible for a 50% refund or credit.

**No refund or credit will be given if a cancellation is made on the day of the program or later.**
